- 1. Completion of the application including all signatories = 10 points**
- 2. Letter of recommendation from SCR member that addresses the financial need and character of the applicant = 15 points**
- 3. Evaluation of financial need = 30 points**
- 4. Academic and extra curricular achievements = 30 points**
- 5. Applicant's essay = 15 points**
